Research: The EHE Foundation funded research projects in basic and translational science aimed to advance knowledge in the disease, enabling the identification of effective treatments for EHE. In addition to funding external research, the Foundation funded and advanced patient-led research initiatives including biobanking of EHE biospecimens, development of a global patient registry, and expanding EHE cell-line development. The Foundation continued its growth of a global patient-led research network, including clinician-scientists, researchers, and advocates in a scientific symposium.
